*Enbridge Gas New Brunswick distributes natural gas to institutional, commercial, industrial and residential customers across nine New Brunswick communities.*

- A growing New Brunswick company committed to serving customers with the utmost concern for safety and the environment.
- Enbridge Gas New Brunswick operates as a limited partnership between Enbridge Inc. and several New Brunswick investors.
- Entered into a renewable 20-year natural gas distribution General Franchise Agreement with the Province of New Brunswick in 1999.
- Regulated by the New Brunswick Energy and Utilities Board.
- Owns and operates over 758 kilometres of pipeline for the distribution of natural gas.
- Currently provides natural gas service to nine municipalities in southern New Brunswick – Dieppe, Fredericton, Moncton, Oromocto, Riverview, Sackville, Saint John, St. George, and St. Stephen.
- Enbridge Gas New Brunswick offers bundled services to its customers:
  - Distribution of natural gas (its primary business)
  - Utility gas for sale
  - Sales, installation and service of natural gas equipment and appliances
